The Fund's investment objective is to track the performance, before fees and expenses, of the FaithShares Methodist Values (MV) Index, a custom index by FTSE/KLD.

## Index Description

The MV Index is designed to measure the performance of U.S. large capitalization companies that operate in accordance with the investment philosophy of the United Methodist Church. Companies considered for inclusion in the MV Index are evaluated based on their Methodist Values, which cover the following areas: the natural world; the nurturing community; the social community; the economic community; the political community; and the world community.

FaithShares Advisors, LLC, the Fund's advisor, has committed to donating 10% of the net income derived from each fund back to a ministry or charity supported by that Fund's denomination.
